EMERGENCY POWERS (DEFENCE)

Food (Horseflesh)—General Licence

GENERAL LICENCE, DATED MAY 7, 1942, UNDER THE HORSEFLESH (CONTROL AND MAXIMUM PRICES) ORDER, 1941.

Pursuant to paragraph (1) of Article 11 of the Horseflesh (Control and Maximum Prices) Order, 1941(a), the Minister of Food hereby authorises as follows:—

1. In this Licence the expression "licensed article" means a meat roll or galantine, meat product or other compound article of food containing horseflesh which has been manufactured or prepared for sale for human consumption.

2. Notwithstanding the restrictions imposed by paragraph (2) of Article 6 of the above-mentioned Order, a person may sell or offer or agree to sell or expose for sale for the purpose of feeding animals only any licensed article which he had in his possession on the 24th day of February, 1942, or, being a wholesaler, which he has acquired from a manufacturer who had it in his possession on that date, or, being a retailer, which he has acquired from a wholesaler who had it in his possession on that date or has acquired it from a manufacturer who had it in his possession on that date, subject in each case to the following conditions:—

- (a) every container of a licensed article must bear a label stating the maximum retail price per lb. of the article and that the contents are sold for the purpose of feeding animals only;
- (b) where a licensed article is offered or exposed for sale after removal from the container, a notice stating in plain words and figures the matters mentioned in paragraph (a) hereof shall be exhibited on or in close proximity to the article;
- (c) every person selling a licensed article by wholesale or by retail shall keep the records prescribed respectively in relation to wholesale and retail sales of horseflesh by Article 9 of the above-mentioned Order, and every manufacturer of a licensed article shall keep an accurate record of all sales thereof identifying the person to whom it was sold and containing particulars of the quantity and description of the licensed article sold on each occasion and the price charged;
- (d) no person shall sell a licensed article at a price exceeding the maximum price specified in the Schedule to this Licence.

3. This Licence may be revoked at any time by the Minister either generally or in relation to any person or class of persons.

4. This Licence shall come into force on the 11th day of May, 1942.
