The Public Health (Condensed Milk) (Scotland) Amendment
Regulations, 1953

Made - - - - - 9th November, 1953

Laid before Parliament 11th November, 1953

Coming into Operation 16th November, 1953

The Minister of Food, in exercise of the powers conferred upon him by section one of the Public Health (Regulations as to Food) Act, 1907(a) as extended by section 8 of the Milk and Dairies (Amendment) Act, 1922(b), and by the Transfer of Functions (Food and Drugs) (Scotland) Order, 1949(c), and of all other powers him enabling in that behalf, having consulted such representative organisations as appear to him substantially to represent the interests concerned with the purposes of these Regulations, hereby makes the following Regulations:—

1.—(1) These Regulations shall come into operation on the 16th day of November, 1953, and may be cited as the Public Health (Condensed Milk) (Scotland) Amendment Regulations, 1953.

(2) These Regulations and the Public Health (Condensed Milk) Regulations (Scotland), 1931(d), and, so far as they relate to condensed milk, the Public Health (Condensed and Dried Milk) Amendment Regulations (Scotland), 1943(e), shall be construed as one and may be cited together as the Public Health (Condensed Milk) (Scotland) Regulations, 1931 to 1953.

2. The Public Health (Condensed Milk) Regulations (Scotland), 1931 as amended(f), shall be further amended as follows:—

(a) by adding to Regulation 5 thereof the following sub-paragraph:—

“(c) during the period until 31st December, 1955, the provisions of paragraph (2) of this regulation shall not apply as respects full cream unsweetened condensed milk imported by the Minister of Food and intended for human consumption which contains not less than 7·8 per cent. of milk-fat and not less than 25·5 per cent. of all milk-solids including fat.”;

(b) by substituting for the proviso to Regulation 12 thereof the following proviso:—

“Provided that—

(a) the provisions of this regulation shall not apply in any case where the condensed milk is intended to be re-exported or is contained in a tin or other receptacle the gross weight of which exceeds five pounds;

(b) during the period until 31st December, 1954, the provisions of paragraph (2) of this regulation shall not apply as respects full cream unsweetened condensed milk imported by the Minister of Food and intended for human consumption which contains not less than 7·8 per cent. of milk-fat and not less than 25·5 per cent. of all milk-solids including fat.”.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These amending Regulations permit for a limited period the sale of full cream unsweetened condensed milk, imported by the Minister of Food, containing not less than 7·8 per cent. milk-fat and not less than 25·5 per cent. of all milk-solids including fat.
